Presidential Directive No. 18-32

To establish an Independence Day Committee for the Republic of Palau's 24th Independence Day Celebration on October 1, 2018 and the 25th Independence Day Celebration on October 1, 2019

WHEREAS, on September 23, 1994, President Kuniwo Nakamura executed Presidential Proclamation No. 01-94 establishing October 1 as an annual national holiday to recognize and observe a historic moment in the Republic of Palau that signifies the importance of regaining sovereignty and independence; and

WHEREAS, on October 1, 1994, President Kuniwo Nakamura executed Presidential Proclamation No. 09-94 formally proclaiming the Republic of Palau's independence from the United States of America; and

WHEREAS, this year's Independence Day on October 1, 2018 marks 24 years of our nation's Independence as a sovereign nation; and

WHEREAS, on October 1, 2019, the Republic of Palau will commemorate a significant milestone in our national history as we recognize and celebrate our Silver Anniversary, 25 years of Independence as a self-governing nation, and the extraordinary achievements our young independent nation has accomplished since; and

NOW THEREFORE, by virtue of the authority vested in me under the Constitution and laws of the Republic of Palau, I, Tommy E. Remengesau, Jr., President of the Republic of Palau, hereby direct as follows:

- (1) There shall be an Independence Day Committee that shall be responsible for inviting state dignitaries and other off-island guests, organizing, and planning the events and festivities in celebration of our Independence Day on October 1, 2018 and our Silver Anniversary in celebration of our 25 years of Independence on October 1, 2019.
- (2) The following shall be the members of the Independence Day Committee:
