## INSTRUCTIONS

1. **BUSINESS NAME & MAILING ADDRESS:** Enter Registered Name and Mailing Address as shown on Business License.

2. **ID:** Enter Business Identification number assigned for the company.

- Example: 01234500

3. **DUE DATE:** Enter the Due Date of the tax.

Example: If a device is purchased on March 31, tax must be paid by April 30, and annually on the 31<sup>st</sup> of January.

### **Amusement Device Tax**

Every person who owns a coin-activated amusement device is required to pay a tax for each device within 30 days of its purchase and thereafter annually on or before January 31. **The rate is \$500.00 for each device that simulates the playing of any card game. All other types of devices are taxed at a rate of \$200.00 each.** Report must be made on a form Tax-302 prescribed by BRT.

1. **NUMBER OF AMUSEMENT DEVICES:** Enter the number of the devices that stimulates playing of any card game.

2. **TAX DUE/PAYABLE (BOX 1 x \$500.00)**

3. **NUMBER OF AMUSEMENT DEVICES:** Enter the number of all other devices.

4. **TAX DUE/PAYABLE (BOX 1 x \$200.00)**

5. **TOTAL TAX DUE/PAYABLE (BOX 2 + BOX 4)**

6. **NUMBER OF DAYS LAPSED:** Enter the number of days past the due date.

7. **PENALTY:** Enter the amount of the Penalty. (see formula in front page)

8. **INTEREST:** Enter the amount of the Interest. (see formula in front page)

9. **TOTAL DUE AND PAYABLE:** Enter the sum of #5, 7, and 8.

1. **PRINT NAME:** Print Name of person preparing the tax return.

2. **SIGNATURE:** Signature of the person preparing the tax return.

3. **DATE:** Enter date when the tax return was prepared.
