



## DECEMBER 2019 QTR KEY POINTS

- All groups saw an increase of 0.9% over the last quarter. Groups that showed increases were Transport group
  at 3.4%, Food & non-alcoholic beverages group at 1.6%, and Clothing & Footwear group at 0.7%. Items
  contributing to these increases includes the price change on fuels, meat, bread, and men's clothing. The only
  group that saw a significant decrease was Miscellaneous goods & services group at -1.3%. Item that
  contributed to the decline includes products for personal care. The remaining groups saw little or no change
  this quarter. Overall, prices remained constant with last quarter in respect to their perspective weights in the
  CPI basket.
- The annual increase of 0.6% for the last 12 months was largely driven by Restaurants & Hotels group at 4.6%, Transport group at 1.3%, Clothing & Footwear group at 1.2% and Food & non-alcoholic beverages group at 1.2% respectively. Items that contributed the most to these groups' change includes the price increase of takeout food, fuel, men's t-shirts, bread and frozen chicken. On the other hand, Miscellaneous goods & services group saw a significant decrease of -1.5% mainly due to the price change of personal care products. The remaining groups saw little or no annual price change this quarter.


 Overall, total imports increased by 8.5% over the same period last year.



- Vehicles, aircraft & associated transport equipment group saw and increase of 199.7% largely due to imports of vehicles, boats & floating structures.
- Base metals & articles thereof group also showed an increase of 26.9% likely associated with imports of iron, steel and aluminum.
- Articles of stone, plaster, cement, glass & ceramic products group showed a decline of 23.9%. Imports of construction materials such as stone, plaster, cement, glass and asbestos contributed to last year's high number.



### December 2019 QTR KEY POINTS

- The total number of visitors this quarter was 23,440, an increase of 4,325; 22.6% compared to the same quarter last year.
- PRC China, which was the leading market amongst other countries for the past year, saw a significant increase of 1,643; about 34.1% over the same quarter last year.
- Taiwan saw a significant increase of 1,413; about 60.7% over the same guarter last year.
- Other country group saw an increase of 526; about 60.3% over the same quarter last year.
- USA/Canada saw an increase of 373; about 21.4% compared to the same quarter last year.
- European visitors experienced a decline of 50; about -3.7% compared to the same period last year.

## DECEMBER 2019 QTR KEY POINTS

- Overall, FIAC licenses issued this quarter saw no change to the same period last year. A total of 4 new licenses were issued this quarter with Accommodation and food service activities contributing the highest. Licenses issued for this industry were for hotel development.
- Building Permits issued this quarter by KSG-Building & Zoning increased by 6 over the same period last year.
   A total of 17 building permits were issued this quarter with Residential building permits contributing the highest.
- Earthmoving permits issued for this quarter declined by 5 over the same period last year. A total of 80 earthmoving permits were issued this quarter with Residential permits contributing the highest. All of the earthmoving activities in the Republic of Palau with the exception of minor agricultural/funeral practices require an earthmoving permit from EQPB, whereas, building permits issued by KSG-Building & Zoning are only applicable to projects in Koror State.
