Please be advised that passengers may only board this United Airlines "Fully Vaccinated Passenger" flight if they agree to comply with the following:

1. Passengers traveling into the Republic on this flight must submit proof to the Quarantine Office of completed COVID-19 vaccination with final dose administered at least fourteen (14) days prior to departure from point of origin to Palau. Vaccine received must be approved or have been granted Emergency Use Authorizations from either the US Food and Drug Administration (FDA) or the World Health Organization (WHO).
2. Passengers traveling into the Republic on this flight are required to complete a fourteen (14) day period of self-restriction of movement before departure from point of origin.
3. Passengers traveling into the Republic on this flight must provide a negative Polymerase Chain Reaction (PCR) COVID-19 test results undertaken within seventy-two (72) hours of departure from point of origin to the Republic; and
4. Passengers entering the Republic must undergo a restriction of movement/self-monitoring period for seven (7) days upon arrival into the Republic and must undergo appropriate COVID-19 testing on their 7th day of restriction of movement/self-monitoring as directed by the Ministry of Health.

Restriction of movement is defined as limiting movement to only essential travel such as from residence to workplace/worksites, bank, grocery store and accessing medical care and not attending large gatherings or public events or visiting public places.

Seven (7) day restriction of movement conditions and requirements:

1. For everyone (All Travelers)
 - All travelers must stay at a pandemic safety certified accommodation or their place of residence and limit movement to essential travel only.
 - Ministry of Health staff will conduct daily Covid-19 symptom checks
 - Maintain at least 3-feet distance from others.
 - Must wear a mask at all times while in public.
 - Submit to a PCR test on the 7th day of restricted movement. Ministry of Health will provide instruction prior to test day and notify travelers of test result. [See PCR Testing Guidance.](#)
 - Travelers may be subject to additional testing as deemed necessary by the Ministry of Health.
2. For medical referral patients, accompanying escorts, and other returning residents:
 - Stay home and limit movement to only essential travel.
 - Avoid hosting guests.
3. For essential workers:
 - Travel between their local accommodation and approved worksite location. Essential worker is required to stay at a pandemic certified hotel during restriction of movement period.
 - Any movement outside of these locations is restricted for a period of 7 days.
 - No visitors during 7 days restricted movement period.

Enforcement: Palau's quarantine policies and procedures are legally binding and enforced by the Ministry of Justice. Violation of any mandatory quarantine order is punishable by up to six (6) months of incarceration, and by fines of up to \$500 per violation.
